**HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100**

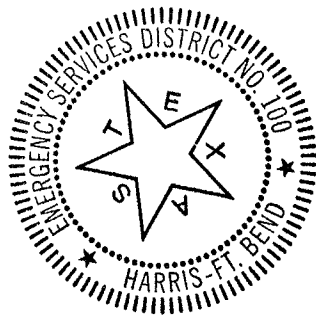

The District will consider and act upon the following matters:

2. To review, discuss and take action regarding any matters related to construction of the new Fowler Training Field including the addition of an EMS training building and any change orders presented.
3. To review, discuss and take action regarding any certified pay applications received from Joiner Architects, the District's architect and Durotech, Inc., the District's general contractor.
4. To review, discuss and take action regarding selection of a general contractor to construct the administrative building addition to Station 1.
5. To review, discuss and take action on needed improvements or repairs to the District's station or related facilities.

16. To receive a report from the website committee and take any necessary action.
17. To receive an operations and financial report from Community Volunteer Fire Department, including dispatch and mutual aid, and to take any necessary action thereon.
18. To review, discuss and take action on requests from the District or Department for equipment purchases and other necessary budgeted acquisitions.
19. To discuss and take action to confirm the August 7, 2018 regular monthly meeting date as well as any items that need to be on the next meeting agenda.
